

- 1. SETTLER COLONIALISM IS NOT IMMIGRATION, IT IS A VIOLENT INVASION THAT FUNCTIONS ON INDIGENOUS ELIMINATION.**  
AMERICA WAS FOUNDED BY SETTLER COLONIALISM, WHICH IS A TYPE OF COLONIALISM THAT FUNCTIONS AS AN INVASIVE STRUCTURE DEPENDENT ON THE ONGOING ELIMINATION OF INDIGENOUS POPULATIONS IN ORDER TO ASSERT SETTLER SOVEREIGNTY. THIS ELIMINATION IS SEEN THROUGH THE GENOCIDE OF 80+ MILLION INDIGENOUS PEOPLES, FORCED ASSIMILATION (THROUGH NATIVE BOARDING SCHOOLS), CONTINUED DISAPPEARANCES OF INDIGENOUS WOMEN AND TWO SPIRIT PEOPLES, RESOURCE EXTRACTION / VIOLATIONS OF TREATIES, AND MUCH MORE.
- 2. KIDNAPPED AFRICANS WHO WERE FORCIBLY BROUGHT TO TURTLE ISLAND AS SLAVES, WERE NOT IMMIGRANTS.**  
AFRICAN SLAVES WERE CONSIDERED "PROPERTY" BY COLONIZING FORCES AND WERE VIOLENTLY TRANSPORTED BY SLAVE SHIPS TO BUILD THE SETTLER COLONIES ON STOLEN INDIGENOUS LANDS.
- 3. RACIST LAWS OPPOSING IMMIGRATION HAVE BEEN THE NORM.**  
AMERICAN STATE PROPAGANDA SAYS "GIVE ME YOUR TIRED, YOUR POOR..." BUT IN REALITY THEY MEANT "GIVE ME YOUR WHITE PEOPLE." IN 1882 THE CHINESE EXCLUSION ACT WAS PASSED, PROHIBITING ALL IMMIGRATION OF CHINESE LABORERS AND THE U.S. BORDER PATROL ORIGINATED AS THE "MOUNTED GUARDS" IN EL PASO, TEXAS, WHOSE PRIMARY PURPOSE WAS TO RESTRICT THE ILLEGAL IMMIGRATION OF CHINESE PEOPLE.

# Investigation #2 - Formal US Immigration Policies


[Naturalization Act of 1790](#) - People had to resided in the country for two years and had kept their current state of residence for a year to apply for citizenship.

[Naturalization Act of 1795](#) increased the residency requirement to five years residence and added a requirement to give a three years notice of intention to apply for citizenship and the [Naturalization Act of 1798](#) further increased the residency requirement to 14 years and required five years notice of intent to apply for citizenship.

[Naturalization Law of 1802](#) repealed and replaced the Naturalization Act of 1798. The "free white person" requirement remained in place. The alien had to declare, at least three years in advance, his intent to become a U.S. citizen.

The first federal statute restricting immigration was the [Page Act](#), passed in 1875. Federal Government argument is that they didn't want Chinese women to become prostitutes. Real reason is that they barred Chinese women so that male Chinese workers who came to work on the railroad, didn't start families in the US.

Congress passed the [Chinese Exclusion Act](#) in 1882, barring Chinese laborers for 10 years and establishing grounds for deportation of any Chinese person found unlawfully in the US.



During 1885 and 1886, at least 168 communities carried out Chinese expulsion and self-deportation campaigns. These campaigns resulted in the destruction of Chinese businesses, homes and several massacres.




The Chinese Must Go.

Nine members of the Cigarmakers' Union of this city will leave Saturday to join the army that is going to California to help drive out the Chinese. They will meet a train load of tobacco rollers at Chicago going in the same direction. E. B. Griffith, formerly of Michigan, now located in San Francisco, writes that there are situations for about 2,000 white cigarmakers in that city, the war on the Chinese having been a success.

The Chinese Exclusion Act was renewed in 1892 by the [Geary Act](#) for another ten years, and in 1902 with no terminal date. It was repealed in 1943, although large scale Chinese immigration did not occur until 1965.



**Eugenics Movement becomes more mainstream during this time.**



After President [William McKinley](#) was [assassinated](#) by an anarchist of immigrant parentage, Congress enacted the **Anarchist Exclusion Act in 1903** to exclude known anarchist agitators.

The [Naturalization Act of 1906](#) created the Bureau of Immigration and Naturalization (INS) to maintain centralized records of naturalization and to impose uniform nationwide procedures, forms, and certificates.

A [literacy requirement](#) was added in the [Immigration Act of 1917](#).

**Sedition Act of 1918**, to cover a broader range of offenses, notably speech and the [expression of opinion](#) that cast the government or the war effort in a negative light.

The **Committee on Public Information** (1917-1919), also known as the **CPI** or the **Creel Committee**, was an independent agency of the government of the United States created to influence public opinion to support US participation in World War I.

In just over 26 months, from April 14, 1917, to June 30, 1919, it used every medium available to create enthusiasm for the war effort and to enlist public support against the foreign and perceived domestic attempts to stop America's participation in the war. It used mainly propaganda to accomplish its goals.

Anti-German attitudes were cultivated during WWI, such as this cartoon here on the right.

The Committee on Public Information also played a significant role in shifting public opinion to support going to war, because Germans were being demonized.

The **Palmer Raids** were a series of raids conducted in November 1919 and January 1920 by the [United States Department of Justice](#) under the administration of President [Woodrow Wilson](#) to capture and arrest suspected [socialists](#), especially [anarchists](#) and [communists](#), and [deport](#) them from the United States.

The raids and arrests occurred under the leadership of Attorney General [A. Mitchell Palmer](#), with 6,000 people arrested across 36 cities. 556 foreign citizens were deported, including a number of prominent leftist leaders.

In 1921, the United States Congress passed the [Emergency Quota Act](#), which established national immigration quotas limiting immigration from the [Eastern Hemisphere](#).

The [Immigration Act of 1924](#) (Johnson-Reed Act), set national quotas as a fraction of 150,000 in proportion to the national origins of the entire [White American](#) population. Under the 1924 Immigration Act is when the US Border Patrol was created.





In 1932, [President Hoover](#) and the State Department essentially shut down immigration during the [Great Depression](#) as immigration went from 236,000 in 1929 to 23,000 in 1933.



The public then supported the rounding up of thousands of Japanese Americans, which were put into internment camps.





Anti-Semitism is widely accepted and practiced in US culture.

During WWII, the US refused to allow thousands of Jewish people who were fleeing Nazi Germany.


The [Immigration and Nationality Act of 1952](#) (the McCarran–Walter Act) revised the National Origins Formula, again allotting quotas in proportion to the national origins of the population as of the 1920 census, but by a simplified calculation taking a flat one-sixth of 1 percent of the number of inhabitants of each nationality then residing in the U.S.

At the beginning of “Operation Wetback” there were roughly 700 US Border Agents. By 1962, the number increased to 1,692.

The [Refugee Act](#) of 1980 established policies for [refugees](#), redefining "refugee" according to [United Nations](#) norms. A target for refugees was set at 50,000 and the worldwide ceiling for immigrants was reduced to 270,000 annually.

In 1986, the [Immigration Reform and Control Act](#) resulted in:

- First time penalties for employers who hired undocumented immigrants
- An increase in the budget and activities of the US Border Patrol
- Amnesty for 3 million undocumented people who were already in the United States.









# U.S. Immigration and Customs Enforcement

The Immigration and Naturalization Service (INS) was disbanded and gave rise to ICE in 2003.




***“Both the Antiterrorism and Effective Death Penalty Act (AEDPA) and the Illegal Immigration Reform and Immigrant Responsibility Act (IIRAIRA) were passed that year. Together they changed the paradigm on immigration to one that emphasized citizenship rather than residency and laid the legal foundation for the expansion of the deportation machine that emerged following 9/11.”***




***The Obama administration expanded and set up a powerful machinery for Trump to exploit by plugging in the detention and deportation system much more closely to criminal law enforcement across the country.***

# Immigrant Detention Centers in the US







# SPREAD INFORMATION, NOT PANIC: REMEMBER S.A.L.U.T.E.

**S** SIZE AND STRENGTH - It's critical to report how many ICE or federal agents and vehicles you see. If there are different law enforcement agencies or local police, note the number of agents and agencies involved.

**A** ACTIVITY AND ACTION - What is happening? A traffic stop? Is ICE targeting specific individuals? Are ICE vehicles circling a school? The more information, the better.

**L** LOCATION - Where did you see ICE? At a school or local business? At someone's house? Take note of the cross streets and if ICE is going in a specific direction.

**U** UNIFORM - Specify what agents are wearing. Are they wearing civilian clothing, uniforms, or vests? Masks, face coverings, hats, shades, or anything else concealing their identity? What do any badges or vests say?

**T** TIME AND DATE - One of the most critical pieces of information to note when reporting or posting about ICE sightings is the time and date ICE was spotted.


**E** EQUIPMENT AND WEAPONS - Are ICE agents carrying weapons? Identify any equipment agents have (including guns, tear gas, pepper spray, or other weapons) and whether they use them on people.

**You have a right to film activity in public spaces. Record at a safe distance and explain what is happening. Remember, report ICE sightings by calling the GR Rapid Response to ICE hotline 616-238-0081.**



# AMAZON Collaborates with ICE to Separate Immigrant Families

The Amazon Web Services' cloud computing platform is the host for Palantir's Investigative Case Management (ICM) software. ICM is then used by Immigration and Customs Enforcement (ICE) to manage their caseload and facilitate the tracking down and deportation of undocumented immigrants. Palantir, a data analytics firm, receives taxpayer dollars to provide these algorithms to government agencies, with its ICE contract being worth over \$51 million. For its part, Amazon in turn receives \$600,000 a month from Palantir. In addition, Amazon's new home-security company (Ring), works with hundreds of law enforcement agencies and ICE to provide video from the Ring system that can also be used to target the undocumented community.
